

Declaration of Finances

Following U. S. visa regulations, Oregon State University and/ or University of Oregon cannot provide a Letter of Admission until you submit satisfactory evidence that you have adequate funds for your proposed program of study. **Current financial documents** must accompany this form. An acceptable financial document must have been issued not more than nine (9) months before you intend to enroll at OSU or UO. Please keep copies of these documents to present to the U.S. Consulate at your visa interview and to U.S. Immigration officers at your port of entry. **U.S. Immigration regulations restrict student employment. You should not expect to supplement your income with employment during your program of study.**

Costs: The table below reflects the approximate costs for an undergraduate student at any OSU or UO campus. **Study at OSU-Cascades will be significantly less, but you must demonstrate funding sufficient for the main campuses of UO or OSU (see website for details).** These figures cover the cost of tuition and a modest estimate for room, board, books and supplies, insurance (required of all international students and accompanying family members), and incidental expenses. Costs for summer term tuition and books are not included in the above estimates. These figures below are estimates for the **2006/2007** academic year and are subject to change for 2008/2009. Cost tends to increase from year to year. To help you make your financial plans, be aware that Undergraduate Bachelor's degree programs are typically from 4 to 5 years in length. **Please remember that you and/or your sponsor must be prepared to meet the ongoing costs of your educational and living expenses, not only for the first 12 months, but also for the entire duration of your studies.**
